1.	Product called “Banana Cream” in the form of banana-shaped foam pieces covered with a cocoa coating (20%). Its ingredients are as follows: sugar, cocoa coating 20% (sugar, vegetable fat (soya), cocoa powder with a reduced cocoa butter content (min. 5%), emulsifiers (soya lecithin, E476) and salt), maltose syrup, water, milk coating 4 % (sugar, vegetable fat (soya), dried whey (from milk), soya flour, emulsifiers (soya lecithin, E476), salt), dextrose, gelling agent (E406), egg white powder, acidity regulator: citric acid (E330), flavour, corn starch, preservative (E202) and colour (E100). 2.	Product presented in liquid form and packaged in a 30 ml spray bottle for retail sale. It consists of propolis extract, peppermint essential oil, honey, glycerine, xanthan gum, citric acid, potassium sorbate, flavouring and water. According to the information provided, it improves general health and helps relieve sore throats and pharyngitis, coughs and various infections by strengthening the immune system. Preparation used in animal feeding, in the form of a free-flowing powder, composed of maduramicin ammonium (maduramicin as ammonium salt) (0.75 %), nicarbazin (8 %) (active ingredients) and corn cob (carrier). It is put up in 25 kg bags and must be mixed into feed at a dosage of 500 g per tonne of feed. The product is used in broiler chickens for the prevention of coccidiosis caused by <i>Eimeria acervulina</i>, <i>Eimeria maxima</i> and <i>Eimeria tenella</i> and as an aid in the prevention of coccidiosis caused by <i>Eimeria necatrix</i>, <i>Eimeria brunetti</i> and <i>Eimeria mivati</i>. 11.	Product consisting of a sterile, vacuum-dried form of purified Botulinum toxin type A, produced from a culture of Clostridium botulinum. It is presented in a clear glass vial containing a small white vacuum-dried powder cake. The strength of the product is specified as 100U and 50U per vial. Its indications for use are therapeutic applications for several conditions and cosmetic applications for the management of skin and skin appendage disorders. The dosage and direction for use are specific to each individual indication. Solution containing sodium hyaluronate (1.8 mg/ml) as well as excipients: sodium chloride, potassium chloride, dibasic sodium phosphate dodecahydrate, sodium citrate, magnesium chloride hexahydrate, calcium chloride dihydrate, hydrochloric acid and/or sodium hydroxide to adjust pH, and water for injection. It is hypotonic and free of preservative. Its indication for uses is the treatment of dry eye which may improve ocular surface damage due to some conditions and/or diseases, and the treatment of corneal inflammation or syndromes related to dry eye. It is also used for temporary relief of dryness, burning and ocular fatigue induced, for example, by dust smoke, dry heat, air conditioning, prolonged computer uses or contact lens wear. If not otherwise recommended, one or two drops of the product is placed into the conjunctival sac of the eye as often as needed. After blinking, the solution will disperse and form a transparent and long-lasting coating on the surface of the eye. Each kit contains: - 10 resorbable poly-L-lactic acid threads with microscopic barbs, measuring 190 mm, fed into round tip atraumatic cannulas (20 g/150 mm); - 1 cannula for insertion (23 g/80 mm), of medical-grade stainless steel; and - 1 lancet point needle (18 g/40 mm), of medical-grade stainless steel. The resorbable threads are designed for distributing, gripping and holding the soft tissue in position more firmly following their insertion. The thread is inserted using the cannula and needle; they guide the thread subcutaneously into the correct position in the patient's body. Once the thread has been appropriately positioned for lifting the soft tissue, the cannula and needle are removed. It has a stimulating effect upon plants under physiological stress in their growth and is well compatible with many pesticides. It is presented in packages of 10 litres. According to the labelling indications, this is an “inorganic foliar NPK-suspension fertiliser with boron and micronutrients”. Chemical composition (%): Al: residual amount, S: ≤ 0.50, Fe: ≤ 0.70, C: ≤ 0.10, Mg: ≤ 0.50, Mn: 0.70-1.4, Zn: ≤ 0.10, Hg: ≤ 0.005, Ti: ≤ 0.50, Cd: ≤ 0.005, Pb: ≤ 0.005, other elements: ≤ 0.15 (single element: ≤ 0.05). Actual value (%): Al: 98.37, Si: 0.198, Fe: 0.517, Cu: 0.054, Mg: 0.015, Mn: 0.768, Zn: 0.015, Ti: 0.022, Cd: 0.00040, Pb: 0.0012, other elements: 0.050. Production process: Pure aluminium ingots are melted in a furnace and mixed with other alloying elements. The molten alloy is then poured into moulds and cooled to form solid aluminium alloy blocks with dimensions of 8500 mm x 450 mm x 125 mm. Aluminum with a purity of 99.7% is usually used. In the process of producing a tube, the rondel is cut out of an aluminum sheet, burned, and an aluminum cylinder is pressed from it without heating. Display panel consisting essentially of a light-emitting diode (LED) display with a resolution of 128 x 128 pixels and a distance between two pixels (line and column spacing/pitch) of 3.9 mm, a receiver card fitted with inputs for connecting a display controller to a single display panel via an Ethernet cable or to multiple display panels via interconnecting cables, as well as a power supply cable. The display panels can be assembled to create a large display. It does not include a display controller. The display panel can display all images generated by the graphics card within an automatic data processing machine or other video source and is not confined to displaying specific information.
